Methods	Where to Submit Comments
Web site	Please access the Public Comment website using the URL or 2D barcode listed in the 'Contact for Submission of Comments and Inquiries' then fill in the required information in the form and press the 'Submit' button.
Post or fax	Please complete the attached 'Forms to Submit Comments' and send them to the address list in the 'Contact for Submission of Comments and Inquiries.' Please note that stamps are not required if you send your comments by post.
E-mail	Please send your comments to the e-mail address listed in the 'Contact for Submission of Comments and Inquiries.' Please state clearly in the title and body of the e-mail that your comments are on the draft of the Third Sapporo Future Creation Plan. Please include your name, address, and age group.
Hand delivery	Please directly submit your comments in person at the location listed in the 'Contact for Submission of Comments and Inquiries.' The reception desk is open from 8:45 a.m. to 5:15 p.m. on weekdays.
