# **Sapporo School Expense Assistance Application Procedure**



## The Application Form included

School Expense Assistance is a system that provides financial support to households that are having difficulties paying for expenses for compulsory education such as school supplies. Households whose income is less than the specified amount set by the City are eligible. If you wish to receive this assistance, please read the explanation below and submit an application.

#### 1. Eligible children

- Children who are enrolled in an elementary school or a junior high school as of October 2025.
- Children who will **enroll in an elementary school** in April 2026.

Please regard the primary part of compulsory education schools as elementary school, and the secondary part of compulsory education schools or the first part of secondary education schools as junior high school.

#### 2. Applicable requirements (for receiving school expense assistance)

- (\*1) If the person who supports the household is not living with the family due to job transfer or with the intention of getting a divorce, the person is still considered a member of household even if the place of residence is different. Persons who live together are considered members of the household even if they do not share the household budget or their resident registration is different. If in the middle of divorce mediation or trial, it may be possible not to consider the spouse as a member of the same household.
- (\*2) Medical expenses here are limited to those eligible for deduction from income tax (except in special cases). Expenses for health checkups and vaccinations cannot be included.

- (\*3) Limited to those who are unemployed or have no income at the time of application. Those who have received a special lump sum payment for employment insurance are not eligible.
- (\*4) "Income" refers to the amount obtained by subtracting essential expenses from earnings. In case of a salary, it is not a paid amount but an amount after deduction of essential expenses from the salary.
- (\*5) These amounts are provided only as a guide. Note that the amount of income may vary depending on the number of people who have earnings and the amount of earnings.

#### 3. How to apply

Please apply using one of the following methods;

#### (1) Online Application

Please apply using the QR code on the last page or through the Sapporo City's HP.

\*Only required for some applicants: Documents proving that you meet the eligibility (please refer to item 5 below)

# (2) Written Application

Please submit the application form and other necessary documents to the school your child is attending.

\*For households with children attending different schools (such as elementary and junior high schools), please submit to only one of the schools.

[Items to prepare] Application form, a copy of your banknote or cash card that shows your bank account information.



#### 4. Application deadline

Application deadline: August 29 (Fri.), 2025 (※)

Note: <u>April 30 (Thu.), 2026</u> for households that will apply for only one child who is expected to enroll in elementary school in April 2026

\*Applications are also accepted after the above deadline, but <u>as a general rule, approval will be granted from the month of application. Therefore, there may be items for which the payment amount is prorated by month or items for which you will not receive payments. Additionally, applications are accepted at any time if there are changes in your household's financial situation due to reasons such as divorce or unemployment.</u>



#### 5. Examination method

Among the information required for examination, Sapporo City Board of Education will obtain information on welfare assistance, child-care allowance (*Jido Fuyo Teate*), income and tax amounts directly from the concerned departments of Sapporo City. If you do not give consent for this, contact the Board of Education (School Expense Assistance Section: Email: shugakuenjo@city.sapporo.jp) in advance. If you do not give consent, you cannot apply online and the certificates shown in the table below must be submitted.

Please note that even if you have given consent, you may still have to submit certificates in case the necessary information cannot be obtained from the City, or the City does not have necessary information.



# 7. Outsourcing of administrative procedures

Administrative procedures regarding the application for School Expense Assistance is outsourced to the Sapporo Administrative Office Center, which is under the jurisdiction of Sapporo City.

Therefore, not only the Board of Education but also the Sapporo Administrative Office Center may contact the applicant directly by phone (Center's phone number: 011-350-6750) if the application documents are incomplete or if there are matters that require confirmation.

#### 8. Notification of examination results

The results of the examination will be announced in writing through the school. If there is a child enrolled in a school other than the one where the application is submitted, the Board of Education will also notify the results to the school.

#### 9. Contents of Assistance

Once the School Expense Assistance is approved, the following items will be provided.

Students listed in brackets [ ] are those eligible for the assistance. More details will be informed separately to those who have been approved.


